It is with ample humility, due respect, and great honor that I introduce myself to you in this letter. My name is Steve Pasco and I wish to be considered for the appointment to the JCC Board of Supervisors. I do so with pride, patriotism, and a sense of civic duty. I have never held any office (elected or appointed) at any level of government, but it seems to me that an unknown -- a neophyte devoid of any political baggage might be in just order here. I believe that I can fill the need for non-partisanship on the Board since I have never been registered nor aligned with any political party and have always been independent minded. Below is my biography.

I was born and raised in Norfolk. Graduated Granby HS then went to O.D.U. for 4 years but did not officially receive my B.A. degree until 6 years later on account of some bureaucratic snafus.
