

# James City/Williamsburg Community Center Corporate Fee Information

## **Non-Exchangeable Corporate**

The Employer pays an annual corporate fee of \$550. Each employee would purchase their own 12-month access card for \$145.

## **Exchangeable Corporate**

The employer pays an annual corporate fee of \$550. The employer will also purchase any amount of cards at \$145 per card to distribute at their discretion. You may use the Exchangeable Corporate Pass for employees, volunteers, and clients only. Users of this pass must complete a waiver form before they may use the facility.

## **Corporations with 25 employees or less**

The employer pays an annual corporate fee of \$290. Then they may purchase Exchangeable or non-exchangeable passes \$145 per card.

## **Annual Family Corporate**

*Family Members of employees may also take advantage of corporate memberships:*

The James City/Williamsburg Community Center (JCWCC) is located at 5301 Longhill Road.

Corporate Members must present their employer's identification card (*employee ID card must have an expiration date*) or a current pay stub with a photo I.D. when purchasing and renewing their memberships.

Membership Cards – must be shown each time the patron visits the Community Centers. Patrons may not access the building without their card on consecutive visits unless they purchase a replacement card.

Lost cards may be replaced for a fee of \$5 per card.

Corporate Pass includes the usage of the swimming pool, whirl pool, sauna, basketball and racquetball courts (call no more than 1 day in advance for racquetball court reservations, \$2 rental fee for equipment), lockers/locker rooms, fitness area and indoor track. Please provide a lock for your locker, and lockers are used on a daily basis. Classes are not included in your membership; however you have an option to purchase a wristband for land and water classes for \$30.00 per month (unlimited classes). Please provide your towel and other personal items needed.
