Unfortunately, we are unable to grant requests for specific teams or coaches. Please see next question for information on how we create teams.

Teams are formed based on the number of coaches available, coach's availability to hold practice and the availability of field space. Once coaches have been assigned, practice night requests by participants are then coordinated. **Car-pool and team/coach requests will not be honored.**

Our plans have changed since we turned in our registration and we can no longer have practice on the night our team is scheduled to practice. Can you move us to another team or give a refund?

Changes or refund requests will be accepted until August 2nd. After this date we can not accept changes. Once your child is placed on a team we can not move them to another team as this will affect the balance of the teams.

I would like to coach this season. What do I need to do?

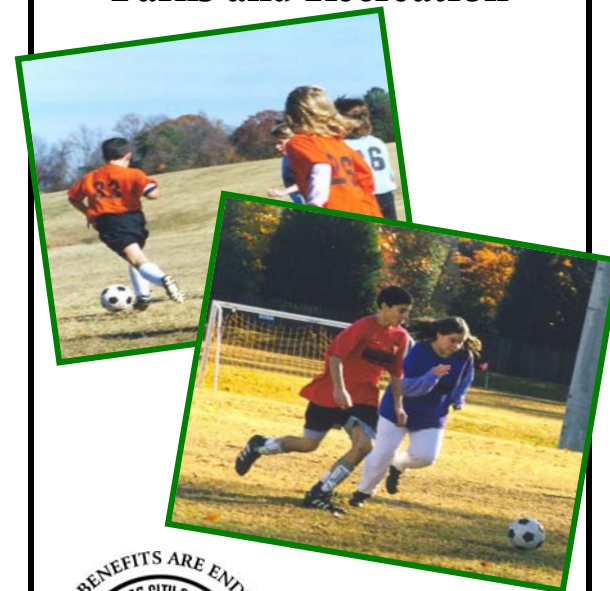

General Information

James City County Parks & Recreation Youth Soccer League is a co-ed league designed to be fun and educational. We offer officiated games, but do not keep standings or conduct tournaments. The focus is to provide a healthy, fun and instructional environment for children interested in playing soccer.

Practices: Coaches may begin practicing the week of August 24th, 2009. If you have not been contacted by a coach by the end of the day on August 16th, please call 259-5355. Please note that call volume is very high during this time and all calls will be returned as soon as possible.

Games: Games will begin on September 12, 2009. Most games are played on Saturdays and each participant will play a minimum of one-half of each game. A minimum of seven games will be played.

Schedules: This program will operate twice weekly with a game every Saturday and practice on a week night. Kindergarten teams will practice and play one game on Saturdays only.

Equipment: Shin guards are required for all players and is the responsibility of the player. Players must also wear socks that cover the shin guards completely. Jerseys will be provided by Recreation Services. Cleats are optional but only soccer cleats with molded bottoms will be allowed.

Rain-Outs: In case of rain or questionable weather, please call the Activities Hotline at 259-3232. The message will be updated each weekday at 3 p.m. and on Saturdays at 8:15 a.m. Games will only be made-up after the 2nd rainout.

Registration DEADLINE: Registration ends Sunday, August 2nd at 6pm.

Late Registrations: Registrations received after the deadline will be placed on the waiting list and assigned to teams on an as-needed basis. There will be a \$10 late registration fee added for registrations received after the deadline.

Eligibility: Residents of James City County, the City of Williamsburg and York County are eligible to register.

Fee: \$45;\$40 for James City/Williamsburg residents. A \$5 multiple child discount will be given for each additional child. Please make checks payable to **Treasurer James City County.**
