CONVERSION TABLE FOR ESTIMATE PURPOSES

Office Paper	1 cu yd	380 lbs	0.19 tons
Newspaper	1 cu yd	433 lbs	0.217 tons
Cardboard	1 cu yd	100 lbs	0.05 tons
Glass	1 cu yd	800 lbs	0.4 tons
Mixed plastic	1 cu yd	32 lbs	0.016 tons
Oil	10 gal	74 lbs	0.037 tons
Aluminum	1 cu yd	62 lbs	0.031 tons

To convert pounds to tons:

Number of pounds/2,000 = _____ tons

Example:

A 4-cubic-yard container of cardboard is collected weekly. To estimate tons per year:

1 cubic yard = 0.05 tons of cardboard (listed above)

4 cubic yards X 0.05 = 0.2 tons

0.2 X 52 weeks = 10.4 tons/year
